The Pennsylvania Game Commission (PGC) is soliciting electronic bids for renovating a shooting range on State Game Lands (SGL) #248. The scope of the project includes removing vegetation that would interfere with the work, demolishing existing tables, concrete slabs and steel target uprights, constructing earth embankments, constructing shooting station shelters, installing new shotgun pattern stations, installing new steel target uprights, constructing stone paths, constructing concrete sidewalks and seeding disturbed earth areas. Bids will be opened electronically in the Division of Contracts and Procurement, 2001 Elmerton Avenue, Harrisburg, PA 17110-9797, on Wednesday, December 13, 2023 at 2:00 PM.

When bidding, amount bid should be in dollars and cents-----no fractions of a cent will be accepted.

Bidders should visit the site to ascertain the pertinent conditions such as existing site conditions, drainage patterns and other working conditions. Contact Zeb Campbell, PGC Southwest Region Group 2 Land Manager at 724-238-9523 to get directions and site information. This is the phone number for the Game Commission's regional office in Ligonier. The dispatchers at the regional office will relay messages to Mr. Campbell. You may also contact Rich Cramer, PGC Indiana County Foreman, at 724-465-2544. This phone number is for the PGC Indiana County maintenance building on State Game Lands #248. The personnel that operate out of this building are frequently in the field; please leave a message and your call will be returned. The project area is open to public travel. Permission is not required to visit the site.

Attached to the project listing in electronic format are Terms and Conditions of Project, Conditions for Construction Contracts and Technical Specifications (Sections 1 through 14). Five drawings titled "Shooting Range Maintenance Project" are also attached. All bids must be submitted electronically using the SRM system and must be submitted by 2:00PM on December 13, 2023. A bid guarantee or bond is not required.

The Commonwealth reserves the right to reject any and all bids, to waive technical defects in bids and to accept or reject any part of the bid deemed in the best interests of the

Commonwealth. Except as otherwise provided by law, award will be made to the lowest responsible and responsive bidder, and all bidders will be advised of the bid results. A Purchase Order will be generated at the time of award without further input from the successful bidder. Awarded vendor will be sent a copy of this document and no work will be authorized until the vendor is in receipt of the Purchase Order.

All vendors who conduct business with the Pennsylvania Game Commission must have a Vendor No. assigned to them in order to receive payment from the Commonwealth.
