The Pennsylvania Game Commission (PGC) is soliciting electronic bids for renovating a rifle / pistol range on State Game Lands (SGL) #77. The project consists of demolishing existing structures, clearing and grubbing the proposed pistol range area, excavating and grading the pistol range area, constructing an embankment on the rifle range, constructing covered shooting station shelters, installing steel target lines, installing a drainage pipe and inlets, and placement of AASHTO #10 aggregate for stone paths, target lines and backstop facing. Surfacing the existing parking area with stone is also part of this project. Bids will be opened electronically in the Division of Contracts and Procurement, 2001 Elmerton Avenue, Harrisburg, PA 17110-9797, on Wednesday, February 7, 2024 at 2:00 PM.

**When bidding, amount bid should be in dollars and cents-----no fractions of a cent will be accepted.**

Bidders should visit the site to ascertain the pertinent conditions such as existing site conditions, drainage patterns and other working conditions. Contact Shawn Seeley, PGC North Central Region Group 3 Land Manager at 570-398-4744 to get directions and site information. This is the phone number for the Game Commission's regional office outside the town of Jersey Shore. The dispatchers at the regional office will relay messages to Mr. Seeley. You may also contact Patrick Donahue, PGC Clearfield County Foreman, at 814-583-7649. This phone number is for the PGC Clearfield County maintenance building on State Game Lands #331. The personnel that operate out of this building are frequently in the field; please leave a message and your call will be returned. The project area is open to public travel. Permission is not required to visit the site.

Attached to the project listing in electronic format are Terms and Conditions of Project, Conditions for Construction Contracts and Technical Specifications (Sections 1 through 23). Five drawings titled "Rifle / Pistol Range Project" are also attached. All bids must be submitted electronically using the SRM system and must be submitted by 2:00PM on February 7, 2024. A bid guarantee or bond is not required.

The Commonwealth reserves the right to reject any and all bids, to waive technical defects in bids and to accept or reject any part of the bid deemed in the best interests of the Commonwealth. Except as otherwise provided by law, award will be made to the lowest responsible and responsive bidder, and all bidders will be advised of the bid results. A Purchase Order will be generated at the time of award without further input from the successful bidder. Awarded vendor will be sent a copy of this document and no work will be authorized until the vendor is in receipt of the Purchase Order.

All vendors who conduct business with the Pennsylvania Game Commission must have a Vendor No. assigned to them in order to receive payment from the Commonwealth.
