Addendum Changes:

This addendum is to answer questions in response to IFB 6100064270.

Question 1: As it is a convenience kit, would you like test strips added?

Answer 1: No. Per the Appendix-A Statement of Work, Section B. Technical Requirements, the convenience kits shall include one hard case containing one medical grade CPR mask and one pair of nitrile gloves. The hard case shall be large enough to also store one box of 2 single-dose naloxone nasal spray.

Question 2: Regarding Statement of Work, Section B. Technical Requirements; can the Commonwealth clarify on whether the kit price should include a box of 2 single-dose naloxone or just a pair of gloves and CPR mask?

Answer 2: To clarify, the kit price should not include a box of 2 single-dose naloxone. Per the Statement of Work, Section B. Technical Requirements, the convenience kits shall include one hard case containing one medical grade CPR mask and one pair of nitrile gloves. The hard case shall be large enough to also store one box of 2 single-dose naloxone nasal spray.

Question 3: Upon review, if there are bid terms and conditions the Vendor may not be able to agree to, will the Commonwealth allow the Vendor to include clarifications or exceptions as part of its bid submission?

Answer 3: PART V., V.1 CONTRACT - 001.1b Contract Terms and Conditions (Nov 30, 2006) states: "The Contract with the awarded bidder (who shall become the "Contractor") shall include the following terms and conditions." These are the terms and are not negotiable. No inclusion of clarifications or exceptions are permitted.

Question 4: What was the previous pricing? Also, is this the same size and scope as the previous contract?

Answer 4: There is no current or previous contract for the specific product requested.

Question 5: Would you kindly confirm if this is an entirely new effort or is there an incumbent currently providing these services? If so, would you please provide the incumbent contract details?

Answer 5: Yes, this is a new effort. There is no current or previous contract for the specific product requested.

Question 6: What will be the contract value for this opportunity?

Answer 6: The Department shall award the lowest bidder.

Question 7: I am having some challenges submitting for this bid online after we created our account online. I can't find where to submit online. Can you please help point us in the right direction?
