Would each be able to apply or would only one application be accepted for this solicitation?	See Section 1-13. General Eligibility Requirements. A single entity may not hold more than one CTF grant at one time. Organizations with multiple partners may apply as one entity. In the example provided in the question, and based on the information provided, it appears that the subsidiary branches could be treated as independent organizations and submit separate applications.

Awaiting an inspection does not prohibit a daycare provider who is providing an Evidence-Based or Evidence-Informed program that focuses on the parent or primary caregiver and their child, or the whole family, from applying for a CTF grant. Applicants should review the RFA, including Section 1-4. RFA Focus Statement, to determine if they are eligible and able to provide the type of program this RFA is intended to support.
