Please find attached to the solicitation the following a revised Appendix H, Cost Submittal, for the subject RFP. Please disregard all previous versions.

Changes to Appendix H, Cost Submittal are as follows:

- For all Lots, Year 1 is for 11 month, August 1, 2017 to June 30, 2018 to align with the state fiscal year.
- For Lot 1 – For Year 1, the selected Offeror will provide IEB services to individuals eligible for CHC beginning January 1, 2018. Offerors should provide a PMPM for NFI Dual Eligibles and a PMPM for LTSS Eligibles for its IEB services for the period of January 1, 2018 through June 30, 2018.
- For Lot 2 – For Year 1, the selected Offeror will only be enrolling individuals in the HCBS Waivers beginning January 1, 2018. Offerors should submit one PMPM for the IEB services provided to the HCBS Waiver population for the period of January 1, 2018 through June 30, 2018. For Years 2 and 3, the selected Offeror will be providing IEB services to individuals eligible for CHC for the entire year. Offerors should provide a PMPM for NFI Dual Eligibles and a PMPM for LTSS Eligibles for its IEB services.
- Lot 3 – For Year 1, the selected Offeror will only be enrolling individuals in the HCBS Waivers beginning January 1, 2018. Offerors should submit one PMPM for the IEB services provided to the HCBS Waiver population for the period of January 1, 2018 through June 30, 2018. For the first six months of Year 2, the selected Offeror will only be enrolling individuals in the HCBS Waivers for the period of July 1, 2018 through December 31, 2018. Offerors should provide one PMPM for IEB services provided to the HCBS Waiver population for this six month period. For the period of January 1, 2019 through June 30, 2019 and Year 3, Offerors should provide a PMPM for the NFI Dual Eligibles and a PMPM for the LTSS Eligibles eligible for CHC.
