We have received several questions, questions and answers below:

Q: On page 4 – Section 4 Eligibility to Bid. Section 4B states that the bidder must be an Original Equipment Manufacturer (OEM) or authorized reseller or dealer. If the Bidder is not the OEM, the Bidder must submit written certification from the OEM for which a bid is submitted. The OEM certification should be on OEM letterhead and must be dated no earlier than the IFB opening date.

Can you please clarify this requirement found in the Aftermarket Parts IFB # 6100064011.

A: OEM stands for Original Equipment Manufacturer. It refers to a company that produces components or equipment that are used in the final product of another company. Should "The Bidder" Auto Parts not be the original manufacturer of parts that you are selling you will need a letter from each manufacturer stating, "The Bidder" Auto Parts is authorized to sell their products.

Q: Do you have any manufacturer numbers for part number 321078?

A: These are the two part numbers that have been used for material number **321078**. Clevis Assembly/Kit: MER E11430A and API E11430A

Q: On the bid, we need more clarifications on some of the Battery numbers?
