The following questions have been asked. Below are the questions and the answers

Q: Can we get more information on material number 311195, such as brand?

A: Fisher's - 330 31-950 PREMIUM BATTERY 224.08 141.95 Battery- Commercial - 24 mo ..  
FMP - FVP 31TXXHD BATTERY CCA1000 RC200

Q: 308120 & 308125 tire chains 000-2814 & 000-2851 tire chains - are these cam style?

A: Yes

Q: 308140 #000-9022 rubber circle type with hooks or spider bungee style with 6 arms?

A: Has not been purchased for the last two years, quote most available version

Q: Lastly, if no "OR EQ", "OR EQUIVALENT" or "OR EQUIVALENT" is specified in "Description and Part Number" does that indicate no substitution, that specific manufacturer & part number only?

A: This means you can quote a competing brand that is Equivalent to the brand specified. The Commonwealth reserves the right to determine if that brand is indeed Equivalent and may require the submission of cuts, illustrations, drawings, prints, test data sheets, specification sheets and brochures used, applicable dimensions and any other pertinent information which the Department of General Services may require in order to evaluate the product(s) offered.

Q: We have a question about the 05 – Reciprocal Limitations Act Requirement form.

Since we do not offer any of the commodities listed on this form, are we required to submit this form or just certain sections of this form?

A: To be responsive bidders must fill out Sections “III” and “IV” As you are supplying parts from various manufacturers list the manufacturers that you represent and the State they are based in.

Q: There are a few lines on the bid that don't have part numbers...just descriptions. Would you be able to help me identify the part numbers you have on file? The list of items is below.

A: Here is the list and the part numbers:

Q: So, 309268 COVER HUB INTL TRUCK seems to specify both with, and without plug.

309267 HUB WET-WHEEL STENCO 343-4009 specifies Stemco item with drain plug. FRO 343-009 Hub Cap 57.21 VEL320178 SOLENOID IS INAVAILABLE

If 309268 specifies drain plug equipped, it seems that would be a duplicate quote. If it (309268) does not intend to specify "drain plug equipped" then the SKF 1643 is not the correct part number for "no drain plug" & seems like it that part number should be parts of item # 309267.
