

**PENNSYLVANIA STATE POLICE
SPECIFICATIONS
FOR
FIREARMS PURCHASE**

1. **SCOPE:** The Pennsylvania State Police (PSP) is issuing this Invitation for Bid (IFB) to procure 150 Sig Sauer P227R, .45 ACP, Nitron, SLITE, DA.SA firearms. The firearm specifications and quantities are set forth in these specifications as are those for all related products and services. This is a no substitute bid for the firearms and listed accessories. The only firearm that will be accepted for this bid is the Sig Sauer P227R, .45 ACP, Nitron, SLITE, DA.SA firearms. The items listed under Training Equipment and Accessories are required. The unit price for each new firearm shall include the firearm as specified herein along with all accessories listed and all training required.
2. **METHOD OF AWARD:** As a result of this bid, the PSP will award a Contract to the lowest responsive and responsible bidder.
3. **DELIVERY LOCATION:** The firearms shall be delivered fully factory assembled and duty-ready. The awarded bidder shall provide weapon serial numbers prior to shipment to the PSP contact person listed below. The firearms, all training, equipment, and accessories must be delivered no later than 30 days after receipt of purchase order. The awarded supplier shall contact Steve McCutcheon at 717-705-5932 no less than seven calendar days prior to delivery in order to coordinate the delivery of the items.

5. **TRAINING:** Firearm instructor training for cadet curriculum and transition training (train the trainer) for 15 personnel shall be provided by the awarded bidder at a time and location to be determined. All training and training materials as set forth in this specification shall be included in the unit price of the firearms.
6. **TRADE-IN OF USED WEAPONS:** As part of this Invitation for Bid, PSP desires to trade in 150 Glock Model 21 firearms. The firearms included in the trade-in are new and are in excellent condition. The trade-in price for the used firearms shall be entered into the spreadsheet on Attachment A and submitted along with the bid. The trade-in value shall be deducted from the total bid price for the new firearms, accessories and training to determine the lowest bid price.
7. **FEDERAL LICENSE REQUIRED:** All Bidders must be a Sig Sauer dealer/distributor authorized to sell to Pennsylvania law enforcement and must have a Federal Firearms License and a Pennsylvania Firearms License. A copy of their authorization to sell in Pennsylvania and copies of both the Federal and Pennsylvania Firearms Licenses shall be attached to the bid. If these documents are not included with the bid, the Department shall request the documents and, upon request, the bidder shall provide such within 3 business days.
8. **PAYMENT:** Payment shall be made upon satisfactory delivery of all merchandise and shall include the final itemized trade-in values.
