The personnel that operate out of this building are frequently in the field; please leave a message and your call will be returned. The project area is gated and may not be open to public travel. Permission is not required to visit the site; however, we recommend contacting Mr. Briggs or Mr. Hubler for directions and for status of road conditions before going to the site.

Attached to the project listing in electronic format are Terms and Conditions of Project, Conditions for Construction Contracts and Technical Specifications (Sections 1 through 11). Three drawings titled "Newell Road Project" are also attached. All bids must be submitted electronically using the SRM system and must be submitted by 2:00PM on February 21, 2024. A bid guarantee or bond is not required.

The Commonwealth reserves the right to reject any and all bids, to waive technical defects in bids and to accept or reject any part of the bid deemed in the best interests of the Commonwealth. Except as otherwise provided by law, award will be made to the lowest

responsible and responsive bidder, and all bidders will be advised of the bid results. A Purchase Order will be generated at the time of award without further input from the successful bidder. Awarded vendor will be sent a copy of this document and no work will be authorized until the vendor is in receipt of the Purchase Order.
