The Pennsylvania Game Commission (PGC) is soliciting electronic bids for shotgun and pistol range construction on State Game Lands (SGL) #043 in Warwick Township, Chester County. The scope of the project includes construction of concrete slabs, shooting station shelters, target holders, excavation work, and related improvements. Bids will be publicly opened and read in the Division of Contracts and Procurement, 2001 Elmerton Avenue, Harrisburg, PA 17110-9797, on **Thursday, April 18, 2024, at 2:00 PM.**

When bidding, the amount bid should be in dollars and cents-----no fractions of a cent will be accepted.

Bidders should visit the site to ascertain the pertinent conditions such as access, site contours, proximity of utilities and existing structures and vegetation in the work area. Contact Land Management Group Supervisor Alex Murray at 717-949-2519, or Angela Lindgren at the number listed above for detailed directions to the site. Access to the site is open to the public and prior permission to visit is not required, however please contact Mr. Murray or Ms. Lindgren for questions on site conditions.

Attached to the project listing in electronic format are Terms and Conditions of Project, Conditions for Construction Contracts and Technical Specifications (Sections 1 through 9). Drawings (6 pages) titled "Shooting Range Improvements" are also attached. These documents are all part of the electronic proposal. All bids must be submitted electronically using the SRM system and must be submitted by **2:00 PM on Thursday, April 18, 2024.** A bid guarantee or bond is not required.

The Commonwealth reserves the right to reject any and all bids, to waive technical defects in bids and to accept or reject any part of the bid deemed in the best interests of the Commonwealth. Except as otherwise provided by law, an award will be made to the lowest responsible and responsive bidder, and all bidders will be advised of the bid results. A Purchase Order will be generated at the time of the award without further input from the successful bidder. The awarded vendor will be sent a copy of this document, and no work will be authorized until the vendor is in receipt of the Purchase Order.

All vendors who conduct business with the Pennsylvania Game Commission must have a Vendor Number assigned to them to receive payment from the Commonwealth.
