# Specification Sign Stiffeners and Accessories Scope of Work

## 1. SCOPE/OVERVIEW:

This Invitation for Bid (IFB) 6100060825, (identified here and in the other documents as the "Contract") will cover the requirements of the Commonwealth of PennsylvaniaDepartment of Transportation (Department), for Sign Stiffeners and Accessories for the short term. Estimates are for Immediate Need. Delivery of all items is required FOB Destination within 60 calendar days of receipt of the purchase order for this one-time need purchaser order. Extensions of delivery time are available at the Department's discretion for documented supply chain issues, upon submission of acceptable documentation to the Department and the Department's acceptance of such documentation.

## 2. WORKER PROTECTION AND INVESTMENT CERTIFICATION:

Such certification shall be made through the Worker Protection and Investment Certification Form (BOP-2201) and submitted with the bid, proposal, or quote. This bid will be awarded to the lowest responsive and responsible bidder. This bid solicitation has been reserved for Small Business Contracting. Only those Bidders certified as DGS Small Businesses through the Small Business Contracting Program may submit a bid for these services. Unless all Bids are rejected, and except as otherwise provided by law, award will be made through the issuance of a contract/purchase order in accordance with the method of award. As a condition for receipt of award of a contract/purchase order, the Bidder must be registered in the Commonwealth of Pennsylvania's Vendor Master file.
