To All Suppliers:

The Commonwealth of Pennsylvania defines a solicitation "Addendum" as an addition to or amendment of the original terms, conditions, specifications, or instructions of a procurement solicitation (e.g., Invitation for Bids or Request for Proposals).

As per SERS RFP #23-028 section 2.3. Pre-Proposal Conference and Written Questions, A pre-proposal conference will be held at SERS offices and virtually on February 8, 2024. (Beginning at 3 p.m. eastern standard time.) Each proposer may attend the pre-proposal conference where the procurement process and technical requirements of the proposal will be presented, and offerors will be provided the opportunity to ask clarifying questions.

Getting there from Street Level

The street level entrance to SERS is located on Third Street between Wells Fargo Bank and the Whitaker Center.

From Walnut Street Garage

- Take the elevator to floor "A".
- Go up the stairs (or take the ramp) and turn left.
- Take the walkway on the left across from the giant shopping bag and Wells Fargo ATM
- Go down the stairs on the right (or take an elevator). At the bottom of the stairs, turn left.
- Go past the security guard to the elevator bank, to the 5th floor.
- When you get off the elevator at the 5th floor you will see SERS' lobby directly ahead, please enter, and register.

From Strawberry Square Food Court

- From the food court, take the walkway that crosses above Third Street toward the Hilton
- Take the walkway on the right across from the Wells Fargo ATM and giant shopping bag. It's before the entrance to the Whitaker Center.



- Go down the stairs on the right (or take an elevator). At the bottom of the stairs, turn left.
- Go past the security guard to the elevator bank to the 5th floor.
- When you get off the elevator at the 5th floor you will see SERS' lobby directly ahead, please enter, and register.
